The World Trade Organization (WTO) is an international trade organization known for its enforceable dispute resolution procedure. One of the principle functions of WTO is resolution of international trade disputes. The disputes may arise between the member nations of WTO whenever there is violation of agreement or commitment in the WTO. However, the WTO has an international mechanism to deal with these cases with the help of Dispute Settlement System(DSS). The process of DSS issues rulings on disputes over the WTO members according to their right and obligations which may subject to be reviewed by a standing Appellate Body (AB) of DSS. The decisions delivered by the AB are final and binding, respected by the parties to the disputes. Since its incorporation in 1995, the WTO DSS has resolved number of cases relating to trade disputes because of which it recognized as a 'crown jewel' of the world trade system.[1] However, this dispute settlement mechanism of WTO is going through crisis because the WTOmembers are failing to update the rulebook containing the rules of dispute settlement. Also, the US officials have restricted the appointments of AB members to obligate the WTO members to negotiate the new rules. Given this background, it is pertinent to check whether, the process of WTO dispute resolution is being affected by inspite of the objective of promptness of WTO's DSS in resolving international trade conflicts.[2]
